INFORMATION & CONDITIONS OF ENTRY

1. A maximum of 50 entries will be accepted for the Annual NSW Masters, Webb Bros Working Dog Auction.
2. An entry fee of \$55.00 inc GST per dog/starter must accompany each entry form.
3. The Auctioneer reserves the right to ballot out dogs in order to obtain the desired quality, number and variety of ages.
4. Entries received on or before 30 September 2011, will incur a 7.5% commission on the sale price. **Late entries will be charged at 15% commission.**
5. Webb Bros Property & Livestock guarantees that vendors will receive payment of the auction price, less commission payable, within 28 days of the auction.
6. Normal auctioning terms and conditions apply and will be displayed on the day.
7. The Auctioneer's decision will be final.
8. Vendors are invited to demonstrate their dogs from **2.30pm** on auction day. The organizers will supply an area.
9. Any Vendor who allows their dogs to work in a manner that the Auctioneer decides may lead to cattle being mistreated or injured will be asked to cease their demonstration immediately.
10. All dogs demonstrated must be put up for auction. No dog is to be traded prior to auction. Only dogs entered for auction are to be sold on the day.
11. Any vendor wishing to place reserves on their dogs must do so at the office no later than 2.00pm on the day of the auction. Dogs with no reserve will be sold to the highest bidder.
12. The auctioneers will hold any dog "passed in" at auction, for 30 minutes after the auction, so negotiations can continue between vendor and under bidders in the presence of a steward. No dog is to be sold for less than the reserve price.
13. All dogs presented for auction must have no known or suspected health problems.

14. Any dog that the vendor suspects or knows may display aggressive behavior towards humans & other dogs must not be entered.
15. Vendors will be responsible for the restraint, control and well being of their dogs throughout the day
16. Bitches on heat are not permitted at Gloucester Showground on the day.
17. No pups **under 6 months** of age are to be entered or sold.
18. Webb Bros Property & Livestock requests that all vendors be at Gloucester Showground and register at the office no later than 2.00pm on the auction day.
19. Webb Bros Property & Livestock reserves the right to allocate the order of demonstrations. Vendors must demonstrate their dogs at the allocated time. Demonstrations are conducted between 2.30pm and 5.15pm and vendors failing to demonstrate their dogs during the allocated time will forfeit the opportunity to do so.
20. All vendors must submit a current vaccination certificate for each dog entered. Pups over 6 months, a minimum of distemper/hepatitis/parvo. The dog must have been vaccinated in the last 12 months, but not less than 2 weeks prior to auction. This should be done whilst registering at the office on auction day prior to 2.30pm. If your dog remains unsold, you may collect your certificate from the office following the auction.
21. Any registered buyer wishing to charge purchase/purchases to their Stock Agents account must provide a letter of introduction from the Manager of their local branch on Auction Day. There is no rebate available from this sale.

Catering available at the venue throughout the day by the Gloucester Lions club. A presale catalogue will be posted to entrants two weeks prior to the auction.
